PACKAGED LIGHT DETECTOR SEMICONDUCTOR DEVICES WITH NON-IMAGING OPTICS FOR AMBIENT LIGHT AND/OR OPTICAL PROXIMITY SENSING, METHODS FOR MANUFACTURING THE SAME, AND SYSTEMS INCLUDING THE SAME

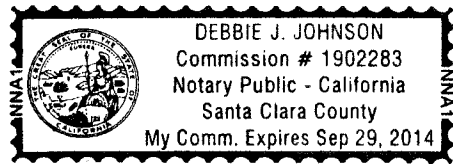
