

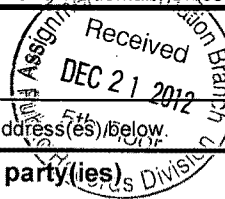



Seller promises and agrees to promptly execute such further and additional forms, documents, instruments, and writings as may be necessary, proper or required, for the purpose of fully effectuating the terms and provisions of this Bill of Assignment and specifically the conveyance of the Patents as provided herein, including any forms of the United States Patent and Trademark Office for recording conveyances or transfers of registered patents.

THE PATENTS ARE TO BE SOLD AND CONVEYED ON AN "AS IS" AND "WHERE IS" BASIS WITHOUT ANY REPRESENTATIONS OR WARRANTIES OTHER THAN THOSE SET FORTH IN THE AGREEMENT.


