STATUTORY DECLARATION

I, Christopher Crowell, do solemnly declare that:

1. I make this statement in respect of the amalgamation of Chantry Networks Inc., Siemens Enterprise Communications Inc./Siemens Communications d'Entreprise Inc. and Enterasys Networks of Canada Limited/Réseaux Enterasys du Canada Limitée (the "Amalgamation") pursuant to Section 185(2) of the *Canada Business Corporations Act* (the "Act").
2. I am the President of Chantry Networks Inc. (the "Corporation").
3. I am satisfied that there are reasonable grounds for believing that:
