THIRD: The name of the surviving domestic limited liability company is Reynolds Packaging Holdings LLC.

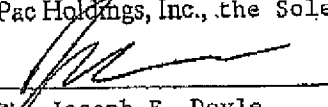
FOURTH: The merger of RPLLC, Food Packaging and Kama into Holdings shall be effective on November 8, 2012 at 12 p.m.
