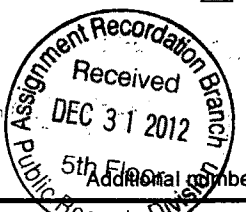


Patent Purchasing Agreement
