## ASSIGNMENT

WHEREAS, I, Joseph Sandor (below referred to as ASSIGNOR), residing, respectively, as set forth hereinafter, have made an invention for which application for Letters Patent of the United States was filed in the United States Patent and Trademark Office as Application Serial No. 09/706,550, filed November 6, 2000, and granted as U.S. Patent No. 6,290,392, with a patent grant date of September 18, 2001, naming the ASSIGNOR as inventor, and entitled RECLOSABLE PLASTIC BAG WITH DEFORMABLE, STAY-OPEN INLAY; and

ASSIGNOR hereby covenants that ASSIGNOR has full right to convey the entire interest herein assigned, and that ASSIGNOR has not executed, and will not execute, any agreement in conflict herewith;

ASSIGNOR agrees to communicate to ASSIGNEE or to its successors, assigns or legal representatives any and all facts known to them or any of them respecting said invention, and without further remuneration to testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and reexamination applications, make all rightful oaths and generally do all lawful acts to aid ASSIGNEE or its successors, assigns or legal representatives to obtain and enforce proper patent protection for said invention in all

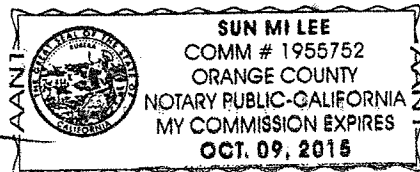
countries and to enhance or perfect ASSIGNEE's title in and to the invention and patent rights therein.
