I hereby authorize and request the Commissioner of Patents and Trademarks of the United States and any Official of any country or countries foreign to the United States, whose duty is to issue patents or other evidence or forms of industrial property on applications as aforesaid to issue the same to Apollo Marine Specialties, Inc., its successors, assigns and legal representatives, or to such nominees as it may designate.

I agree that, when requested, I will, without charge to Apollo Marine Specialties, Inc. but at its expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and maintaining patents for the inventions in any and all countries and for vesting title thereto in Apollo Marine Specialties, Inc., its successors, assigns and legal representatives or nominees.


