WHEREAS, I, Timothy C. Loose and Jacob C. Greenberg, have invented certain new and useful improvements in the following:

Simulation Of Mechanical Reels On A Gaming Machine

for which I have made application for United States Letters Patent, the said application having been executed by me concurrently herewith;


I also hereby sell and assign to said ASSIGNEE, its successors, assigns and legal representatives the full and exclusive rights, title and interest to the invention disclosed in said


