AND ASSIGNOR, his successors and assigns, hereby agrees to execute without further consideration any further lawful documents and any further assurances, and any divisional, continuing, reissue, or other applications for patents of any country, that may be deemed necessary by said ASSIGNEE fully to secure to said ASSIGNEE its interest as aforesaid in and to said INVENTION or any part thereof, and in and to said several patents or any of them;
