ASSIGNMENT

WHEREAS, We, Vladimir I. Arezina, Thomas M. Kopera, Larry J. Pacey, David Pryor and Richard T. Schwartz, have invented certain new and useful improvements in the following:

HANDHELD DEVICE FOR WAGERING GAMES

for which we have made application for United States Letters Patent, the said application having been filed on January 27, 2006, as Application No. 60/762,744;

We further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.

We hereby further agree that we will communicate to said ASSIGNEE, or its successors, assigns and legal representatives, any facts known to me respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all provisional, divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.

We further authorize and direct the ASSIGNEE and its attorneys to insert above the application number of said application now identified as Docket No. 47079-00452PL01 as soon as the same shall have been made known to them by the U.S. Patent and Trademark Office.
