## ASSIGNMENT OF INVENTION

### UNIVERSAL

WHEREAS, **UNIVERSITÉ DE MONTRÉAL**, 2900 Edouard-Montpetit Blvd., Montreal, Quebec, Canada H3C 3A7 (hereinafter referred to as the “**Assignor**”) is the owner of the entire rights, title and interest in and to the invention entitled Use of live bacteria for growth promotion in animals” and described in international patent application number PCT/CA2005/000138 and filed on February 3<sup>rd</sup>, 2005 in the following countries: Russia, Australia, Europe, Brazil, China, Canada, United States, Philippines;

Assignor further agrees, without any payment by said Assignee other than expenses incurred by the undersigned, to communicate to said Assignee, its representatives or agents, any facts relating to said invention, including evidence for interference purposes or for other proceedings, whenever requested; testify in any interference, litigation or other proceedings, whenever requested; and to execute

and deliver, on request, all lawful papers required to make any of the foregoing provisions effective, and likewise make these provisions binding upon Assignor's successors, administrators and assigns.
