
ASSIGNMENT

WHEREAS Vinny K. 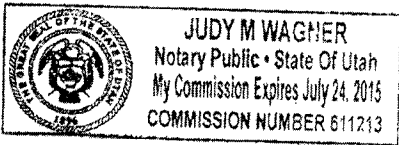
