ASSIGNMENT

WHEREAS, Steven S. Schuver is a citizen of the United States, residing at 223 Lancaster Drive, St. Louis, Missouri 63105, David D. Schuver is a citizen of the United States, residing at 1709 Rosearbor Drive, St. Louis, Missouri 63146, and Thomas L. Bakos is a citizen of the United States, residing at 202 Pleasant Valley Drive, Ridgway, Colorado 81432 (hereinafter "ASSIGNORS"), have invented certain improvements in a patent application entitled SYSTEM AND METHOD FOR PROVIDING A GUARANTEE WITHIN A DEFERRED ANNUITY FOR INSURING A SECURITY, for which an application for Letters Patent of the United States Patent was filed on January 25, 2013, having been assigned application number 13/750,516 by the U.S. Patent and Trademark Office;

AND ASSIGNORS DO HEREBY authorize and request the Commissioner of Patents and Trademarks to issue the said Letters Patent, when granted, to said SBH, its successors and assigns, as assignee of the entire right, title, and interest in and to said improvements, for the sole use and behoof of said SBH, and for its successors and assigns to the full ends of the terms for which Letters Patent may be granted.

AND ASSIGNORS further grant to SBH, its successor and assigns, the right to claim for any application for patent for said improvements the full benefit of any international agreement between the United States and any foreign country or countries.

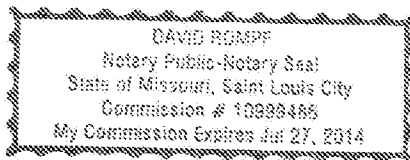

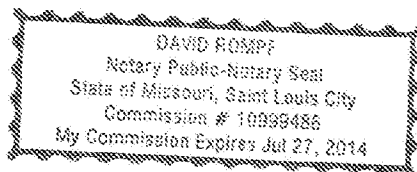
