## PATENT SECURITY AGREEMENT

THIS PATENT SECURITY AGREEMENT is entered into and effective this 27th day of December, 2012, by and between WWRD Ireland IPCo LLC, a Delaware limited liability company ("**Grantor**"), and Bank of America, N.A., a national banking association with a principal place of business at 335 Madison Avenue, New York, NY 10017 ("**Agent**"). Grantor and Agent are sometimes collectively referred to herein as the "**Parties**". Capitalized terms used herein but not otherwise defined shall have the meanings given to them in that certain Loan Agreement, dated as of the date hereof, by and among the Grantor, the other Obligors party thereto, the Lenders party thereto and the Agent (as the same may be amended, restated or otherwise modified from time to time).

### RECITALS

A. Grantor is the owner of the patents and patent applications set forth in **Exhibit A** attached hereto.

B. Pursuant to that certain Amended and Restated General Security Agreement, dated as of July 27, 2012 among the Parties hereto and the other Obligors party thereto, as amended by that certain First Amendment to Amended and Restated General Security Agreement, dated on or about the date hereof (as may hereafter be further amended, modified, supplemented, extended, renewed, restated or replaced, the "Security Agreement"), and subject to the terms of the Intercreditor and Subordination Agreement, Grantor has granted to Agent, as agent for the Secured Parties, a second priority lien on and security interest in and to certain assets of the Grantor, including without limitation the patent assets described in Recital Paragraph "A" and more fully defined herein below as the "Patent Collateral", and a first priority lien on and security interest in and to certain other assets of the Grantor

C. Pursuant to the Security Agreement and subject to the terms of the Intercreditor and Subordination Agreement, the Parties hereto wish to confirm Grantor's grant to Agent of a second priority lien on and security interest in and to the patent assets described in Recital Paragraph "A" and more fully defined herein below as the "Patent Collateral".

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

1. Grantor hereby grants to the Agent, for the benefit of the Secured Parties, and the Agent hereby accepts from the Grantor, subject to the terms of the Intercreditor and Subordination Agreement, a second priority lien on and security interest in and to all of Grantor's right, title and interest in, to and under the following (all of the following items or types of property collectively referred to herein as the "Patent Collateral"), whether presently existing or hereafter arising or acquired:

- (i) all of the patents and patent applications referred to in **Exhibit A** hereto, including without limitation all reissues, reexaminations, divisionals, continuations, and continuations in part thereof;

- (ii) all licenses associated with the use of any of such patents;
- (iii) all products and proceeds of the foregoing, including without limitation any claim by or accruing to Grantor against third parties for the past, present or future infringement, violation, misuse or misappropriation of any such patents.

2. This security interest is granted in conjunction with the security interest granted to the Agent for the benefit of the Secured Parties in assets of the Grantor, as set forth more fully in the Security Agreement and is subject to the terms of the Intercreditor and Subordination Agreement.

3. The rights and remedies of the Agent with respect to the security interest in the Patent Collateral made and granted hereby are without prejudice to and without limitation of those rights and remedies of the Agent which are set forth in the Security Agreement, the terms and provisions of which are in no way limited, qualified, amended or negated by this Patent Security Agreement.

4. In the event of any conflict between the terms and provisions of this Patent Security Agreement and those of the Security Agreement, the terms and provisions of the Security Agreement shall govern and control.

5. Subject to paragraph 4 hereof, this Patent Security Agreement sets forth the entire agreement and understanding between the Parties hereto with respect to the subject matter hereof, and supersedes all prior agreements, drafts of agreement, understandings and commitments, whether oral or written, related to such subject matter.

6. This Patent Security Agreement may only be modified or amended by a further agreement in writing executed by both Parties hereto.




