CONFIRMATORY ASSIGNMENT

WHEREAS, INNOTEK POWDER COATINGS, LLC (the "ASSIGNOR"), a Texas limited liability company having a principal place of business at 3400 W. Seventh, Big Spring, Texas 79720 entered into that certain Asset Purchase Agreement dated September 12, 2012 ("Purchase Agreement") pursuant to which PROTECH CHEMICALS LTD./PROTECH CHIMIE LTEE. (the "ASSIGNEE"), a Canadian limited liability company having a principal place of business at 7600 Henri Bourassa West, St-Laurent, Quebec, H4S 1W3, agreed to purchase from ASSIGNOR, and ASSIGNOR has agreed to transfer to ASSIGNEE, among other things, all of ASSIGNOR'S rights, titles, and interests in and to certain trademarks and patents;


WHEREAS, pursuant to the Purchase Agreement, ASSIGNOR and ASSIGNEE executed a separate Trademark Assignment and a separate Patent Assignment, both effective as of September 17, 2012 (collectively, the "Assignments");

WHEREAS, the Assignments included an inadvertent error in the naming of ASSIGNOR, referring to ASSIGNOR as Protech Chemicals, Ltd. rather than Protech Chemicals Ltd./Protech Chimie, Ltee.;

WHEREAS ASSIGNOR and ASSIGNEE desire to confirm the rights assigned through the Assignments in ASSIGNEE'S proper name;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, ASSIGNOR hereby confirms assignment to ASSIGNEE of all rights, title and interest in and to (1) the trademarks appearing in the attached SCHEDULE (the "MARKS"), along with the U.S., Canadian, and European Community Registrations for the MARKS (the "REGISTRATIONS") and the goodwill of the business connected with the MARKS and the REGISTRATIONS, and symbolized by the MARKS and the REGISTRATIONS; (2) U.S. Patent No. 5,520,736, issued on May 29, 1996, and the invention covered thereby (the "PATENT"); and (3) the right to sue for past common law causes of action and infringement related to the MARKS, REGISTRATIONS, and PATENT.
