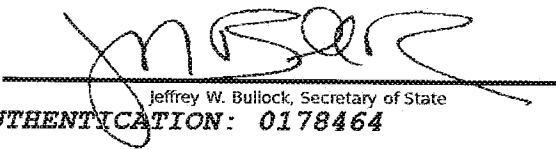

CERTIFICATE OF INCORPORATION

MATURE WOMEN'S HEALTH SOLUTIONS, INC., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "DGCL"), does hereby certify:

**FIRST:** The Board of Directors of the corporation, acting in accordance with the provisions of Section 242 of the DGCL, have adopted resolutions to amend and restate Article I of the Certificate of Incorporation to read as follows:

**ARTICLE I**
