ASSIGNMENT

Assignor avers that all statements made herein of Assignor's own knowledge are true and that all statements made on information and belief are believed to be true, and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment of not more than five (5) years, or both, under 18 U.S.C.

§ 1001 of the United States Code and that such willful false statements may jeopardize the validity of the application or any patent issued thereon.
