Inventor hereby authorizes and requests the attorneys of record in said applications to insert in this Assignment the filing dates and serial numbers of said applications when officially known.

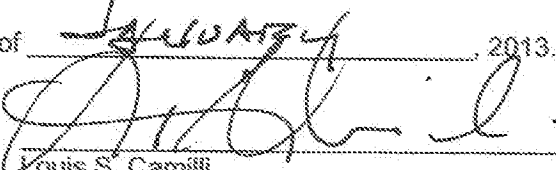

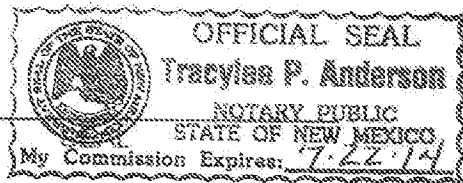
