Assignor further agrees that, upon request and without further compensation, but at no expense to Assignor, he and his legal representatives and assigns will do all lawful acts, including the execution of papers and the giving of testimony, that may be necessary or desirable for obtaining, sustaining, reissuing, or enforcing the Patent Application in the United States and throughout the world for the Invention, and for perfecting, recording, or maintaining the title of Assignee, its successors and assigns, to the Invention, and the Patent Application filed, and any patents granted for the Invention in the United States and throughout the world.

Assignor represents and warrants that he has not granted and will not grant to others any rights inconsistent with the rights granted herein.
