FIRST AMENDMENT TO PATENT SECURITY AGREEMENT

This First Amendment ("Amendment") to Patent Security Agreement dated as of April 30, 2009 (the "Agreement") is made as of this 9th day of November, 2012 by and between:

EnvisionIT, LLC, a Delaware limited liability company (the "**Debtor**") with its principal executive offices at 17 Research Park, Suite 200, St. Charles, MO 63304; and

GLA New Ventures, LLC, a Missouri limited liability company, the authorized Secured Party on behalf of all Secured Parties ("**Secured Parties**"), and as the Controlling Interest.

Capitalized terms used and not defined herein shall have the meanings assigned to such terms in the Notes, the SA and the Agreement.

WITNESSETH:

A. On April 30, 2009, Debtor and Secured Parties entered into the Agreement which has been recorded by the Assignment Division of the U.S. Patent and Trademark Office as docket number 101467-0052 on August 26, 2009.

B. Pursuant to the Agreement and the SA, GLA New Ventures, LLC, a Missouri limited liability company, as the authorized Secured Party, and as a Controlling Interest, is entering into this Amendment on behalf of itself and the other Secured Parties.

C. On or about November 9, 2012, Debtor issued a Note to Jim A. Moffit ("Moffit") and Debtor and Secured Parties have amended the SA to add Moffit as a Secured Party.

D. Debtor and Secured Parties desire and intend by this Amendment to add Moffit; as a Secured Party to the Agreement.

Accordingly, Debtor and the Secured Parties hereby agree as follows:

1. Addition of Secured Party. Pursuant to the terms of the Notes, the SA, and the Agreement, the Agreement is amended to add Moffit as a Secured Party. In furtherance and confirmation of the security interest granted by the Debtor to the Secured Parties under the Notes and SA, and as further security for the payment or performance, as the case may be, in full of the Obligations, Debtor here by ratifies such security interest and grants to the Secured Parties, including Moffit, a continuing a security interest, with a power of sale (which power of sale shall be exercisable only following the occurrence of an Event of Default), in all of the present and future, right, title and interest of the Debtor in and to the Patent Collateral.

2. Ratification of Agreement. Except as modified and amended by the Amendment, the Agreement is hereby ratified approved and confirmed by the Debtor and the Secured Parties.
