ASSIGNMENT OF PATENT RIGHTS

Vanden Eynden**, residing at **6177 Brofield Drive, Indian Springs, Ohio 45011** and **Larry Akers**, residing at **105 Taylor Lane, Clarksville, Ohio 45113**, and **Vincent Charles Anthony DiCola**, residing at **8272 Glenhaven Court, Cincinnati, Ohio 45241**, have invented "**LIGHTING**" and having executed a design patent application for United States patent describing the same based thereon, United States Patent Application **Serial No. 29/420,121 Filed on May 4, 2012** (the "Application"), and for good and valuable consideration, receipt of which is hereby acknowledged from **LSI Industries, Inc.**, a United States corporation having its principal place of business at **10000 Alliance Road, Cincinnati, Ohio 45242** (hereinafter "Assignee," which term shall include its successors and assigns), do hereby sell, assign and transfer unto the Assignee, our entire right, title, and interest, in and throughout the United States of America (including its territories and dependencies) and all countries foreign thereto, in and to and under said Application (which term shall include hereinafter where the context so admits all divisional, continuing, reissue, reexaminations and other patent applications based thereon) and the inventions (which term shall include each and every such invention, or part thereof) therein described, and any and all patents and like rights of exclusion (including extensions thereof) of any country which may be granted on or for any of said inventions or on said application; **U.S. Application Serial No. 29/438,248, filed November 28, 2012, is a divisional of this U.S. Application Serial No. 29/420,121.**

And for the same consideration we do also hereby sell, assign and transfer unto the Assignee all our rights under the International Convention for the Protection of Industrial Property, the Patent Cooperation Treaty and all other treaties of like purpose in respect of said inventions and said application, and do hereby authorize the Assignee to apply in our name or in their own name (in a manner to be determined by the Assignee) or their designee, for patents and like rights of exclusion on or for said inventions in all countries, claiming (if the Assignee so desires) the priority of the filing date of said application under the provisions of said Convention, Treaty or any such other Convention or Treaty;

And for the same consideration we do hereby agree for ourselves and for our respective heirs, executors and administrators, promptly upon request of the Assignee, to execute and deliver without further compensation any power of attorney, assignment, original, divisional, continuing, reissue, reexamination or other application or applications for patent or patents or like rights of exclusion of any country, or other lawful documents and any further assurances that may be deemed necessary or desirable by the Assignee fully to secure to it said right, title, and interest as aforesaid in and to said inventions, application, and said several patents and like rights of exclusion, or any of them, all, however, at the expense of the Assignee;


And we hereby represent that we will assist Assignee, at Assignee's request and expense, in the prosecution of all patent applications on the invention(s) assigned by this document, including the Application, and enforcing any patent issuing from these applications. We further represent that we will execute all accurate and truthful documents reasonably necessary or appropriate for these purposes, as requested by Assignee.

And we do hereby authorize and request the Commissioner of Patents and Trademarks of the United States of America and the corresponding Official of each country foreign thereto to issue to the Assignee any and all patents and like rights of exclusion which may be granted in any country upon said application or on or for said inventions;

And we do hereby covenant for ourselves and for our respective legal representatives and agree with the Assignee that we have granted no right or license to make, use or sell said inventions to anyone except the Assignee, that prior to the execution of this deed my right, title and interest in and to said inventions has not been otherwise encumbered by us, and that we have not executed and will not execute any instrument in conflict herewith.
