This Plan of Conversion (the "<u>Plan</u>"), dated August 26, 2011, is adopted for the purpose of converting Lochinvar Corporation, a Tennessee corporation (the "<u>Corporation</u>"), to a Tennessee limited liability company (the "<u>Conversion</u>").

- 1. <u>Certificate of Conversion</u>.
