ASSIGNMENT

WHEREAS, **Wee Joung Kim** of Vista, California 92081, a citizen of the Republic of Korea, **Philip G. Foster** of Vista, California 92081, a citizen of the U.S., and **Joel B. Erickson** of Pierce, Nebraska 68767, a citizen of the U.S. (collectively hereinafter referred to as "ASSIGNOR"), have invented and own a certain invention entitled "**GOLF CLUB HEAD**", for which application for Design Patent of the United States of America has been executed on even date herewith;

division, renewal, substitute or reissue thereof or any legal equivalent thereof in a foreign country for the full term or terms for which the same may be granted, including all priority rights under the International Convention; and ASSIGNOR hereby authorizes and requests the Commissioner of Patents and Trademarks to issue said Letters Patent and any legal equivalent thereof to said ASSIGNEE, its successors and assigns, in accordance with this Assignment.

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment.

ASSIGNOR further covenants that ASSIGNEE will, upon request of ASSIGNEE, be provided promptly with all pertinent facts and documents relating to said application, said invention and said Letters Patent and legal equivalents in foreign countries as may be known and accessible to ASSIGNOR and will testify as to the same in any interference or legal proceeding related thereto and will promptly execute and deliver to ASSIGNEE or its designated legal representative any and all papers, instruments, declarations or affidavits required to apply for, obtain, maintain, issue and enforce said application, said invention and said Letters Patent and said equivalents thereof in any foreign country which may be necessary or desirable to carry out the purposes thereof.


