**TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENT COLLATERAL**

This RELEASE, dated as of November ~~30~~³⁰, 2011 is made by SUNTRUST BANK, in its capacity as Administrative Agent for the Lenders (the "Administrative Agent").

W I T N E S S E T H

WHEREAS, pursuant to the Patent Security Agreement dated April 13, 2010, made by Sechrist Industries, Inc., and its Affiliates (the "Grantors") in favor of the Administrative Agent, a security interest ("Security Interest") was granted by the Grantors to the Administrative Agent in certain collateral, including the Patent Collateral (as herein defined);

WHEREAS, a Security Interest in the Patent Collateral was recorded in the United States Patent & Trademark Office on April 14, 2011 at Reel/Frame 024225/0507; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of the Security Interest in the Patent Collateral, including without limitation those items listed on Schedule I hereto.

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Patent Collateral pursuant to the Patent Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby states as follows:

1. Definitions. The term "Patent Collateral," as used herein, shall mean all of the Grantor's right, title, and interest of every kind and nature as of the date hereof in the Patents (including, without limitation those items listed on Schedule I hereto). The term "Patents" shall have the meaning provided by reference to the Patent Security Agreement.
2. Release of Security Interest. The Administrative Agent hereby, terminates, releases, and discharges its Security Interest in the Patent Collateral, and any right title and interest of the Administrative Agent in such Patent Collateral shall hereby cease and become void.
3. Further Assurances. The Administrative Agent hereby agrees, at the request and expense of the Grantors, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
