**TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENT COLLATERAL**

This RELEASE, dated as of February 5, 2013 is made by JEFFERIES FINANCE LLC, in its capacity as Agent for the Lenders (the "Agent").

W I T N E S S E T H

WHEREAS, pursuant to the First Lien Guarantee and Collateral Agreement dated November 30, 2011, made by Healogics, Inc. (f/k/a National Healing Corporation), and its Affiliates (the "Grantors") in favor of the Agent, a security interest ("Security Interest") was granted by the Grantors to the Agent in certain collateral, including the Patent Collateral (as herein defined);

WHEREAS, a Security Interest in the Patent Collateral was recorded in the United States Patent & Trademark Office on December 2, 2011 at Reel/Frame 027316/0964; and

WHEREAS, the Agent now desires to terminate and release the entirety of the Security Interest in the Patent Collateral, including without limitation those items listed on Schedule I hereto.


NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Patent Collateral pursuant to the Patent Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Agent hereby states as follows:

1. Definitions. The term "Patent Collateral," as used herein, shall mean all of the Grantor's right, title, and interest of every kind and nature as of the date hereof in the Patents (including, without limitation those items listed on Schedule I hereto). The term "Patents" shall have the meaning provided by reference to the Patent Security Agreement.
2. Release of Security Interest. The Agent hereby, terminates, releases, and discharges its Security Interest in the Patent Collateral, and any right title and interest of the Agent in such Patent Collateral shall hereby cease and become void.
3. Filing of the Release; Further Assurances. The Agent hereby authorizes the filing of this Release in the United States Patent & Trademark Office by the Grantors (or the Grantors' designee) at the request and sole expense of the Grantors, and agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
