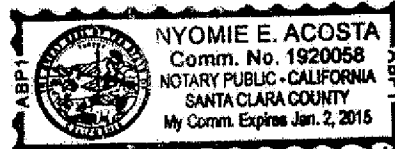
## ASSIGNMENT

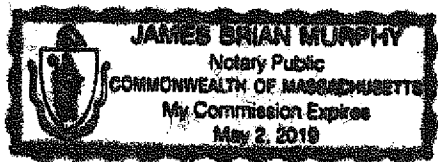

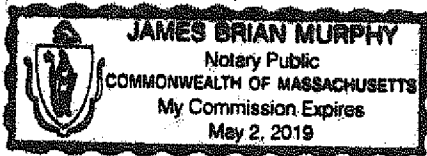

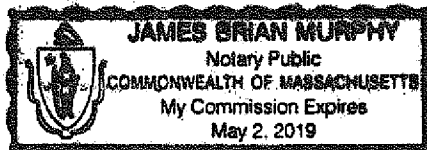
