ASSIGNMENT

IN CONSIDERATION of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, said **CHARLES J. MONTY, PHILIPPE J. CAPRARO**, and **THOMAS S. DOIG**, hereby sell, assign and transfer to said **CAMODO, LLC**, its successors and assigns, the entire right, title and interest in:

HAND HELD IRRIGATION AND SUCTION TOOL

and the invention therein as set forth in their U.S. patent application, Serial No. 13/817,958, filed February 20, 2013, and in and to said application and any divisions or continuations thereof, and any Letters Patent obtained for the said invention in the United States and foreign countries, or issuing out of said application or any such division or continuation thereof, and any reissues or extensions of any such Letters Patent issuing from said application.

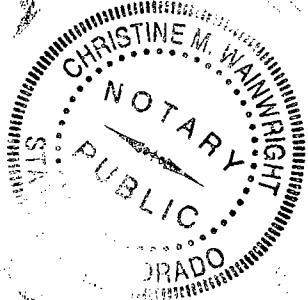



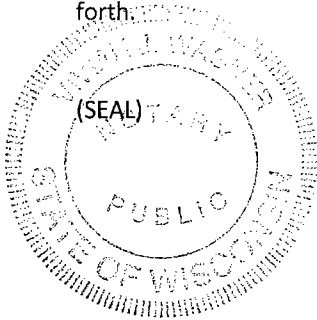
