GRANT OF SECURITY INTEREST IN UNITED STATES PATENTS

February 28, 2013

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, SUMMER INFANT (USA), INC., a Rhode Island corporation with its principal office at 1275 Park East Drive, Woonsocket, RI 02895 (the "Grantor"), hereby grants to BANK OF AMERICA, N.A., a national banking association, as Agent for its own benefit and the benefit of the other Lenders (as defined in the Loan Agreement (as defined below)), with its principal office at Cityplace 1, 185 Asylum Street, Hartford, CT 06115 (the "Grantee"), a continuing security interest in all patents issued or assigned to and all patent applications made by the Grantor (whether established or registered or recorded in the United States or any other country or any political subdivision thereof) (the "Patents"), including, without limitation, those patents and patent applications listed in Schedule A attached hereto, together with any and all (i) rights and privileges arising under applicable law with respect to the Grantor's use of any patents, (ii) inventions and improvements described and claimed therein, (iii) reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof, (iv) income, fees, royalties, damages, claims and payments now or hereafter due and/or payable thereunder and with respect thereto including, without limitation, damages and payments for past, present or future infringements thereof, (v) rights corresponding thereto throughout the world and (vi) rights to sue for past, present or future infringements thereof.

THIS GRANT OF SECURITY INTEREST IN UNITED STATES PATENTS (this "Grant") is made to secure the satisfactory performance and payment of all the Obligations of the Obligors, as such terms are defined in the Loan and Security Agreement dated as of the date hereof (as amended, modified, supplemented or restated and in effect from time to time, the "Loan Agreement") by and among, the Grantor and Summer Infant, Inc., a Delaware corporation, collectively as borrowers, the guarantors from time to time party thereto, the Lenders from time to time party thereto and the Grantee.
