## ASSIGNMENT OF PATENT RIGHTS

Assignor warrants that it is the sole owner of the Patent Rights, and that the Patent Rights are unencumbered. Assignor also agrees to not sign any writing or do any act conflicting with the assignment, and, without further compensation, sign all documents and do such additional acts as Assignee deems necessary or desirable to: perfect Assignee's enjoyment of the Patent Rights; prepare, prosecute, issue and maintain the Assigned Patents; conduct proceedings regarding the Patent Rights, including any litigation or interference proceedings; or perfect or defend title to the Patent Rights. Assignor requests the Commissioner of Patents to issue any Patent of the United States that may be issued on the Invention(s) and/or Assigned Patents directly to Assignee.
