GRANTED PATENTS AND TRADE MARK WITH GOODWILL ASSIGNMENT

THIS ASSIGNMENT dated _____ 11th February _____ 2013 is made by the parties:

- (1) PIKE, Steven Derek (the "Assignor"), a British citizen, whose address is at Unit 16 Ribocon Way, Progress Business Park, Luton LU4 9UR, United Kingdom;
- and
- (2) Argon Electronics (UK) Limited (the "Assignee"), a company incorporated in England and Wales, whose address is at Unit 16 Ribocon Way, Progress Business Park, Luton LU4 9UR, United Kingdom;

WHEREAS:

- A. The Assignor is the owner of the Patents and Trade Mark, as outlined in Schedules A and B respectively;
- B. The Assignor wishes to assign and transfer all his right, title and interest in and to the Patents and Trade Mark to the Assignee, all in accordance with the provisions of this Assignment.

THIS ASSIGNMENT WITNESSES AS FOLLOWS:

1. ASSIGNMENT

- 1.1 *Assignment.* In consideration of the sum of £1 (one pound sterling) now paid by the Assignee to the Assignor (receipt of which is acknowledged), the Assignor hereby assigns and transfers to the Assignee absolutely all their respective rights, title and interests in and to the Patents and Trade Mark, which assignment and transfer is hereby accepted by the Assignee.
- 1.2 This assignment is made with the Goodwill attaching to and symbolised by the Trade Mark
- 1.3 *Further details of the assignment.* The assignment effected by this Clause 1 shall include the assignment and transfer of:
 - (a) all patents and trade marks listed, and all patents that may be granted pursuant to any applications listed, in the attached Schedule, any of the Patents in any country of the world (and including all divisions, continuations, continuations in part, reissues and extensions), and the Patents shall be deemed to include all such items of property;
 - (b) all rights of action, powers and benefits arising from ownership of the Patents and Trade Mark, including the right to sue for damages and other legal and equitable remedies in respect of all causes of action arising before, on, or after the date of this Assignment.
- 1.4 *Further assurances.* The Assignors shall (a) execute, acknowledge, and deliver such further documents; and (b) give such assistance; as the Assignees may [reasonably] require [at the Assignees' reasonable expense] to secure the vesting in the Assignees of all rights in the Patents.

3. GENERAL

- 3.1 The validity, construction and performance of this Assignment shall be governed by English law. Any dispute arising under or in connection with this Assignment shall be subject to the exclusive jurisdiction of the English courts, to which the Parties hereby submit.
- 3.2 *Third parties.* This Assignment does not create any right enforceable by any person who is not a Party.


