ASSIGNMENT OF PATENT

ASSIGNOR hereby agrees to execute all papers necessary to file and prosecute the APPLICATION in the United States and to file and prosecute foreign applications elsewhere throughout the world and to assign the same to ASSIGNEE or any other party acquiring title from ASSIGNEE to said INVENTION, and to execute any other papers that may be needed in connection with filing said applications and securing any and all Letters Patent that may be granted thereon.
