PATENT RELEASE AND REASSIGNMENT

THIS PATENT RELEASE AND REASSIGNMENT is made as of February 28, 2013 by BANK OF AMERICA, N.A., as successor by merger to LaSalle Business Credit, LLC ("Releasing Party").

Releasing Party hereby releases its security interest in Borrower's rights, title and interest in and to all of Borrower's now owned or existing and hereafter acquired or arising patents and patent applications, including, without limitation, the inventions and improvements described and claimed therein, all patentable inventions and those patents and patent applications listed on Schedule A attached hereto and all patents and the reissues, divisions, continuations, renewals, extensions and continuations-in-part of any of the foregoing, and all income, royalties, damages and payments now or hereafter due and/or payable under or with respect to any of the foregoing, including, without limitation, damages and payments for past, present and future infringements of any of the foregoing and the right to sue for past, present and future infringements of any of the foregoing (the "**Patent Collateral**");

2. Releasing Party hereby reassigns, grants and conveys to Borrower, without any representation, recourse or undertaking by Releasing Party, all of Releasing Party's right, title and interest in and to the Patent Collateral.
