And for the same consideration, the ASSIGNORS hereby covenants and agree with ICI that at the time of execution hereof, ASSIGNORS are the sole and lawful owners of the entire right, title and interest in and to the said improvements, inventions and application for Letters

Patent identified above and that the same are unencumbered and that ASSIGNORS have good and full right and authority to sell and convey the same as set forth above.

And for the same consideration, ASSIGNORS hereby agree that they will, whenever requested to do so by counsel for ICI, sign all papers and documents, take all lawful oaths and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of Letters Patent(s) for said improvements or invention(s) without charge to ICI but at the cost and expense of ICI.

ASSIGNORS hereby request the Commissioner of Patents and duly empowered officials in any foreign country to issue Letters Patent in the United States and foreign countries, respectively, to ICI as assignee of said improvements or invention(s) and any Letter Patent to be issued thereon for the sole use and behalf of ICI.
