ASSIGNMENT AGREEMENT

Assignors further agree that in the event any said application, or patent issued thereon, becomes involved in an interference, upon request of Assignee, Assignors will cooperate to the best of their ability with Assignee in preparing the preliminary statement and giving and producing evidence in support thereof. Assignors hereby agree to perform, upon such request, any and all affirmative acts to obtain said patents or similar legal protection, and vest all rights therein in Assignee as fully and entirely as the same would have been held and enjoyed by Assignors if this assignment had not been made.

Assignors hereby covenant and warrant that as of the date hereof they are the true and lawful owners of the entire, right, title and interest in said invention, applications, and patents which may issue pursuant thereto, that they have the full right and power to convey the same, that the same are free and clear of all liens, charges and encumbrances whatsoever, and that they have not executed and will not execute any agreement in conflict herewith.
