

The Assignors covenant that they have full rights and power to enter into this Assignment Agreement and agree that they will communicate to the Assignee or its representative, all facts known to them respecting the Invention, whenever requested, and that they will testify or provide access to personnel to testify in any legal proceeding, and that they will sign all lawful papers, execute all division, continuation and reissue applications, and make all rightful oaths, and generally do everything possible to aid the Assignee, its successors, assigns, and nominees, to obtain and enforce proper patent protection for the Invention in said country.
