ASSIGNMENT

WHEREAS, we, Mark Vincent Greaney, of Vista, California, John Francis Lorentzen, of El Cajon, California, Bing-Ling Chao, of San Diego, California, and Todd P. Beach, of San Encinitas Diego, California, have invented a certain invention as described in the following patent application:

We confirm that at the time the invention was made, we were under an obligation to assign the invention to Taylor Made Golf Company, Inc.

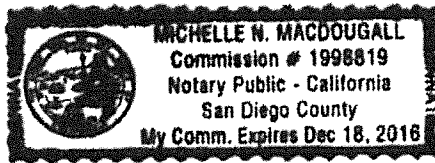
