PATENT ASSIGNMENT

THIS ASSIGNMENT, effective as of the date indicated below, is by and between NFF Inventions, LLC, a company registered in California with its principal place of business at 12229 Falkirk Lane, Los Angeles, California 90049 ("NFF"), on the one hand, and CTI Saginaw I, LLC, a company registered in Texas, with its principal place of business at 500 Sansom Boulevard, Saginaw, TX 76179 ("CTI") on the other hand.

WHEREAS, NFF is the owner of 100% of the right, title, and interest to each of the United States Patents listed in Exhibit 1 (the "Assigned Patents and Applications"); and

WHEREAS, NFF desires to transfer its entire right, title, and interest in and to the Assigned Patents and Applications; and CTI desires to acquire NFF's entire right, title, and interest in and to the Assigned Patents and Applications;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and with the intention of being legally bound hereby, NFF and CTI agree as follows:

1. NFF hereby irrevocably grants, assigns, sells, transfers, conveys and sets over to CTI, free of all encumbrances, the entire right, title, and interest in perpetuity in and to the Assigned Patents and Applications, the inventions disclosed therein, and all embodiments owned by NFF in the United States and worldwide, including:

a. all original, reissued, and re-examined letters patents and patents of addition, and renewals and extensions thereof, that originate there from in the United States and in foreign countries; and

b. all rights to apply, all rights of priority, all continuation, divisional, continuation-in-part and substitute patent applications that may be filed therefore in the United States and in foreign countries; and

c. all original, reissued, and re-examined letters patents and patents of addition, and renewals and extensions thereof, that may issue from said continuation, divisional, continuation-in-part and substitute applications; and

d. all present and future causes of action, the right to enforce and all rights in the Assigned Patents and Applications, the invention disclosed therein, any continuation, divisional, continuation-in-part; substitute patent application, reissued and/or reexamined letters patent or patents of addition, through either legal or administrative proceedings for past and future damages of any sort; the rights to all income derived from the Assigned Patents and Applications and/or the inventions disclosed therein, including the right to all unpaid royalties with respect

to the use of the Assigned Patents and Applications and/or the inventions disclosed therein; and any and all interests, claims, and rights for damages, royalties, profits, settlements, and other awards by reason of any past, present or future infringement, and all other related causes of action, and the right to sue therefore, for CTI 's own use and behalf and for the use and behalf of its Affiliates, successors and assigns or other legal representatives

2. The Assigned Patents and Applications and the inventions disclosed therein is to be held and enjoyed by CTI, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by NFF if this Assignment had not been made.

3. NFF hereby authorizes the United States Patent and Trademark Office and any other governmental agencies having jurisdiction over the Assigned Patents and Applications to identify CTI as the owner of all letters patents issuing from any applications pending related to the Assigned Patents and Applications. NFF further hereby authorizes the United States Patent and Trademark Office and any patent office in any and all foreign countries to issue any and all patents related to the Assigned Patents and Applications, including any and all Certificates of Correction, to CTI as the assignee of NFF's entire right, title and interest in and to the same, for the sole use and behalf of CTI, its successors, assigns, and/or legal representatives, from now through the full end of the term for which any additional patents may be granted.
