ASSIGNMENT

WHEREAS, we, Masato Horie, Takuji Higashioji and Nozomi Yokoyama, all citizens of Japan, and residing at c/o Shiga Plant, Toray Industries, Inc., 1-1 Sonoyama 1-chome, Otsu-shi, Shiga 5208558, Japan (hereinafter referred to as "the undersigned"), having made an invention entitled BIAXIALLY ORIENTED POLYESTER FILM AND LINEAR MAGNETIC RECORDING MEDIUM, identified in International Application No. PCT/JP2011/071238, and in US Application No. 13/822,350, (DLA Piper is authorized to insert the Serial No. when known),

If the undersigned includes more than one individual, these obligations shall apply to all of the undersigned both individually and collectively.
