ASSIGNMENT

WHEREAS, Kabushiki Kaisha Toshiba, a corporation of Japan having a place of business at 1-1, Shibaura 1-chome, Minato-ku, Tokyo 105-8001, Japan (hereinafter referred to as Toshiba), owns, by assignment from Hiroyuki Hasebe, Nobuyasu Negishi, Koichi Kawamura, Shigeo Fukuda, and Motoi Goto, the entire right, title, and interest in and to U.S. Patent Application No. 13/364,919, filed February 2, 2012, for an invention entitled "FUEL CELL" ("Assigned Application"); and


AND, TOSHIBA HEREBY further covenants that Toshiba has the full right to convey the interest assigned by this Assignment, Toshiba will take all action and execute all documents necessary to perfect the interest assigned hereby, and Toshiba has not executed and will not execute any agreement in conflict with this Assignment;

AND, TOSHIBA HEREBY further covenants and agrees that Toshiba, through its officers and employees, will, without further consideration, communicate with Murata, its successors and assigns, any facts known to Toshiba and its officers and employees respecting the invention and testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver all papers that may be necessary or desirable to perfect the entire right, title and interest in the Assigned Application in Murata and its successors and assigns, execute all divisional, continuation, and reissue applications, make all rightful oaths and generally do everything possible to aid Murata, its successors and assigns, to obtain proper patent protection for the invention in the United States, it being understood that any expense incident to the execution of such papers shall be borne by Murata, its successors and assigns.
