

AND said ASSIGNOR(S) DO HEREBY authorize and request the Commissioner of Patents and Trademarks to issue that said Letters Patent, when granted, to the said ASSIGNEE, its successors and assigns, as ASSIGNEE of the entire right, title and interest in and to said improvements, for the sole use and behoof of said ASSIGNEE, and for its successors and assigns, to the full ends of the terms for which Letters Patent may be granted.
