PATENT ASSIGNMENT

THIS AGREEMENT, to be effective as of January 21, 2013, is by and between NTT DOCOMO, INC., a corporation organized and existing under the laws of Japan, having its principal place of business at 11-1, Nagatacho 2-chome, Chiyoda-ku, Tokyo, Japan 100-6150, and NEC Corporation, a corporation organized and existing under the laws of Japan, having its principal place of business at 7-1, Shiba 5-chome, Minato-ku, Tokyo 108-8001 Japan.

WITNESSETH:

WHEREAS, NTT DOCOMO, INC. is the co-owner with NEC Corporation of 100% interest in and to U.S. Patent Application No. 12/064,578, entitled "*Mobile Station, Base Station, Mobile Communication System, And Communication Method*," filed on February 22, 2008, ("the Patent Rights"); and

WHEREAS, NEC Corporation, desires to obtain, and NTT DOCOMO, INC. is willing to assign 100% interest in the Patent Rights to NEC Corporation;

NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged, the parties hereby agree as follows:

NTT DOCOMO, INC. does hereby sell, assign, transfer, and set over unto NEC Corporation 100% of its right, title, and interest in, to, and under (i) U.S. Patent Application No. 12/064,578, entitled "*Mobile Station, Base Station, Mobile Communication System, And Communication Method*," filed on February 22, 2008, (ii) all patents which may issue from such application including any continuations, divisionals, and continuations-in-part thereof, and (iii) the inventions claimed in such patents and applications. After this assignment, NEC Corporation owns 100% of the Patent Rights.
