ASSIGNMENT

This assignment to INGURAN expressly includes MONSANTO's full right to sue for and recover all damages recoverable from past infringement of the Applications and the Patents, all of which is to be held and enjoyed by INGURAN, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by MONSANTO had no assignment of the Applications and Patents been made;


2. MONSANTO hereby agrees for itself, its parent, subsidiaries, affiliates, successors and assigns, to execute without further consideration any further lawful documents and any further assurances, and any provisional, non-provisional, divisional, continuing, reissue

or other applications for patents of any country, that may be deemed necessary by INGURAN, its successors or assigns fully to secure to INGURAN its interest as aforesaid in and to the Patents and the Applications or any part thereof.



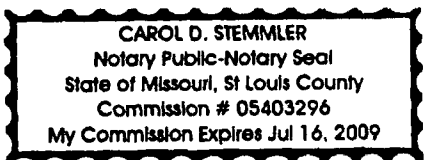

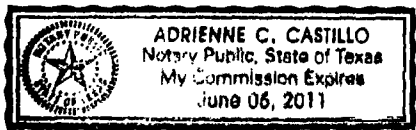
