ASSIGNMENT

WHEREAS, I, Claudio Roberto, residing at Sonnhaldestrasse 2, CH-9533 Kirchberg, Switzerland, have invented certain improvements in:

LARGE PARASOL WITH A TEXTILE FABRIC ROOF

described and claimed in U.S. Patent Application No. 13/737,194 filed on January 9, 2013, and claiming priority in German Patent Application No. DE/202012000527.8 filed on January 20, 2012.

successors, heirs, or assigns, to the full end of the term or terms for which said Letters Patent(s) may be granted, as fully and entirely as the same would have been held by me had this assignment and sale not been made.

I hereby authorize and request the Patent and Trademark Office Officials in the United States of America to issue any and all of said Letters Patent(s), when granted to said Glatz AG, as the assignee of my entire right, title and interest in and to the same, for the sole use and enjoyment of said Glatz AG, its successors and assigns.

Further, I agree to execute all papers and to give such lawful testimony and to perform such other lawful acts as said Glatz AG, its successors and assigns may require to enable it or them to procure Letters Patent on said invention or reissues, reexaminations, or extensions thereof in the United States of America, and/or to hold, enforce or convey said Letters Patent, reissues, reexaminations or extensions.
