## ASSIGNMENT

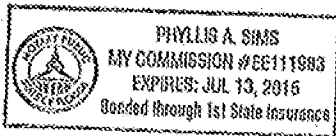

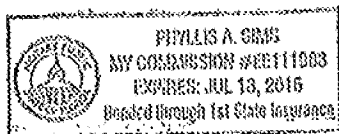
