And I further agree that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said application, said invention and said Letters Patent and





legal equivalents in foreign countries as may be known and accessible to me and will testify as to the same in any interference or litigation related thereto;
