ASSIGNMENT OF U.S.A. RIGHTS IN INVENTION

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN: Be it known that in consideration of the sum of Ten Dollars (\$10.00), the receipt of which is hereby acknowledged, and for other good and valuable consideration, NINOMIYA hereby sells, assigns and transfers to ISHIDA, his successors and assigns within the United States of America (U.S.A.), the entire right, title and interest in and to said INVENTION, including rights in the U.S. PATENT APPLICATION and any application resulting therefrom, including all divisional, continuation, continuation-in-part, reissue or reexamination applications, and rights in all resulting Letters Patent on said INVENTION issuing from the U.S. PATENT APPLICATION or any application resulting therefrom.

NINOMIYA authorizes and requests any official whose duty it is to issue patents, to issue any patent on the U.S. PATENT APPLICATION and any application resulting therefrom to ISHIDA, or his successors or assigns, and agrees that on request and without further consideration, but at the expense of ISHIDA, to communicate to ISHIDA or his representatives or nominees any facts known to NINOMIYA respecting said INVENTION, testify in any legal proceeding, sign all lawful papers regarding said INVENTION or the U.S. PATENT APPLICATION or any application resulting therefrom, make all rightful oaths and generally do everything possible to aid ISHIDA, his successors, assigns, and nominees, to obtain and enforce patent protection for said INVENTION in the U.S.A.
