FIRST: I am married to SHAHNAZ RAHMANI (RAHIMZADEH SAMARI) and we have three (3) children, RAMIN R. SAMARI, male, born Decenber 24, 1962; SHERVIN R. SAMARI, male, born November 5, 1967; and AZIN R. SAMARI, female, born May 22, 1972.

SECOND: I hereby nominate my wife as Executrix. In the event that she is unable or unwilling to so serve, then I nominate and appoint my son, RAMIN, to so serve, and in the event that he is unable or unwilling to so serve, then I nominate and appoint my son, SHERVIN, and if he is unable or unwilling to so serve, then I nominate and appoint my daughter, AZIN, to so serve in the event that she is the age of majority. Any Executor or Executrix shall serve without bond.

THIRD: In the event my wife predeceases me, then I nominate and appoint my eldest son, RAMIN, to serve as guardian of the person and estate of my minor children. It is my desire that bond be waived or a minimun.

FOURTH: I hereby give, devise and bequeath all of my property, wherever located, in the United States or Iran, or elsewhere, to my wife. 
1 to my children equally. In the event that any of my children
