AND WE HEREBY covenant and agree that WE have full right to convey the entire interest herein assigned, and have not made, and will not make, any agreement in conflict herewith;

AND WE HEREBY further covenant and agree that WE will communicate to said ASSIGNEES, their successors, legal representatives and assigns, any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, reissue and foreign applications, make all rightful oaths, and generally do everything possible to assist said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper protection for said invention in all countries.
