**ASSIGNMENT**

WHEREAS, We, Stephen M. Herrington and Zachary B. Suttin, have invented certain new and useful improvements in the following: **“PATIENT-SPECIFIC DENTAL PROSTHESIS AND GINGIVAL CONTOURING DEVELOPED BY PREDICTIVE MODELING,”** for which we have made application for United States Letters Patent;

We hereby further agree that we will communicate to said ASSIGNEE, or its successors, assigns and legal representatives, any facts known to me respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all provisional, divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.


