ASSIGNMENT

NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) and for other good and valuable consideration, the receipt of which is hereby acknowledged, I hereby sell, assign, transfer and set over to **Zehnder Verkaufs- und Verwaltungs AG**, all right, title and interest in and to the said Application for U.S. Patent, and any and all divisions, continuations, reexaminations and reissues thereof, as well as all patents of the United States which may be granted therefrom including any reissues, divisionals, continuations, renewals and extensions and the like (collectively, the "Patents"), the same to be held and enjoyed by **Zehnder Verkaufs- und Verwaltungs AG**, or its own use and benefit, and for the use and benefit of its successors, assigns, or other legal representatives, to the end of the term or terms for which said Patents of the United States are or may be granted or reissued, as fully and entirely as the same would have been held and enjoyed by me if this assignment and sale had not been made.

And I hereby authorize and request the Commissioner of Patents to issue any and all patents on said invention or resulting from said Application and from any and all divisionals, continuations, reissues, reexaminations, renewals, and extensions thereof, to **Zehnder Verkaufs- und Verwaltungs AG**, as assignee of my entire interest, and hereby covenant that I have the full right to convey the entire interest herein assigned, and that I have not executed and will not execute any agreement in conflict herewith.

And I further hereby covenant and agree that I will, at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title of said invention and to such patents as may be granted therefor, to **Zehnder Verkaufs- und Verwaltungs AG**, its successors, assigns, or other legal representatives and that if its successors, assigns or other legal representatives shall desire to file any **Zehnder Verkaufs- und Verwaltungs AG**, divisional or continuation, or to secure a reissue, or reexamination of such patents, or to file a disclaimer relating thereto, will upon request, sign all papers, make all rightful oaths and do all lawful acts requisite for the filing of such divisional or continuation applications, or such application for reissue or reexamination and the procuring thereof, and for the filing of such disclaimer, without further compensation but at the expense of said assignee, its successors, or other legal representatives.

And I do further covenant and agree that I will, at any time upon request, communicate to **Zehnder Verkaufs- und Verwaltungs AG**, its successors, assigns or other legal representatives, such facts relating to said invention and patents or the file history thereof as may be known to me, and testify as to the same in any interference or other litigation when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.
